**Re-opening status:** New re-opening guidelines are now in effect. Puget Sound region is in Phase 1 which allows for very limited indoor fitness and sports programs in addition to the childcare program.

**Programs status:** Full list of program updates and modifications are available as a downloadable document on the <u>website</u>. Latest update was published January 8, 2021.

*Winter programs status: Registration for winter session programs scheduled January-April is open.* 

*Spring-Summer programs status:* Team is working on program line up for the activity guide that goes to printers in late March. Registration will open April 16.

# **Programs currently in operation:**

- School care at Two Rivers School, half day and full day options
- No-school day camps scheduled for MLK Day and Jan 25 professional development day
- Small group Karate in-person classes at Si View
- Small group dance in-person classes at Meadowbrook
- Homeschool in-person art class at Si View
- *Gymnastics and parkour in-person training at Si View*
- Pickleball at Si View (start date Jan 26)
- Adult yoga online classes
- Youth council online meetings
- Self-directed Family Fun Event at Tollgate Farm Park (Jan 30-31)

**Youth Programs:** Si View School Care at Two Rivers School continues to operate with both full day and school hours only options while schools are in remote learning mode. Our average daily attendance in January is staying consistent with 16 students. Hybrid learning launches January 19 for kindergarten students and January 29 for 1st graders. We have aligned our program to work with new school schedules and continue to work with school district on logistics including transportation options, meal service and transition plan for grades 2-5. Our school care program has had unexpected staffing changes as more programs resume at other sites. We are excited to welcome back additional PT staff to assist with program needs.

The Winter Break camp was a success! Participants enjoyed a variety of gym games, arts, crafts and holiday movies hosted at the community center. January has two scheduled No School Days. Mid-winter break is also coming up, and we will be promoting it to the community soon.

Due to current restrictions in place, the Youth Council meetings continue to be hosted virtually.

*Health and Wellness:* Karate classes have resumed in-person instruction at Si View Community Center in small groups. Times have been adjusted to align with latest guidelines. Adult Yoga Class is still fully virtual via Zoom. Other adult health and wellness programs are on hold.

*Youth Sports:* New sport activity guidelines have been released. This allows limited activity in phase 1, and more widespread return to in-person programming in phase 2. Futsal, basketball clinics and volleyball all require move to phase 2. It is also uncertain what if any school access will be available for recreation programs in the coming months.

*Special Interest Programs:* Youth dance classes can continue at Meadowbrook Farm in new Phase 1. A revised January and future February schedule will include shorter class times and smaller class sizes. The longer, 10-week session planned for March-June may need to be broken down into monthly sessions. Three preschool-aged movement classes will be hosted on Fridays in January at Meadowbrook Farm. Gymnastics and Parkour classes can run as scheduled at the community center in January. The Homeschool Art Class is tentatively scheduled at the community center, but staff is seeking clarification on the latest operating guidelines for enrichment type programs.

*Special Events:* Winter *Family Fun Events* are hosted outdoors at our parks. Each event is at a different park with no item sharing and set up for small family groups. Events will be self-directed and open for extended hours so that pre-registered participants can come on their schedule and we can minimize crowding. Events include a fun run/walk, park play day, disc golf, and chalk walk event. January event is themed as a family fun walk/run and will take place at Tollgate Farm Park.

Virtual Holiday Bazaar received mixed reviews from the vendors. While the 10 participating vendors were pleased with our efforts to maintain the event and think creatively, sales were not as high as anticipated. Vendors were able to give constructive feedback and provide ideas to improve a virtual Bazaar in the future.

2021 KC Public Health requirements for farmers market operations have been released. We are in the process of launching vendor application process in early February, with updated requirements and restrictions. The farmers market will operate much like last year, with restrictions on entry/exit points, and limits shoppers and vendors on site.

Food trucks and pop-up shop events are still in the plans. Feedback from vendors recommends launching in April when outdoor recreation programs are back in operation at our parks. Last fall, attendance was best during sports practices.

*Facility and Field rentals:* 2021 rental information packets and rate sheets for all facilities are now in effect. Renewal processes for associated Interlocal Agreements have been completed.
