Sealed bids for TOLLGATE MEADOW MAINTENANCE are requested by Si View Metropolitan Park District at the District Administrative office located at 400 SE ORCHARD DRIVE, North Bend, WA, 98045. Bids will be accepted until 2:00 pm, TUESDAY March 12th, 2019 at which time they will be opened and read publically. Bids will not be received after this time and date. Bids may be mailed or delivered in person and received by time noted. Electronic or faxed bids will not be accepted. Bidders must submit their bid proposal in accordance with Instruction to Bidders.

Project Summary: The project site is approximately 8.66 acres and is located at Tollgate Farm Park, 1300 W North Bend Way, in the City of North Bend, WA.

The Base Bid scope consists of tilling, stripping, earthwork regrading, and reapplication of stripping. The Base Bid work also includes the repair of an existing drainage pipe and associated repair of crushed gravel trail, as delineated in the Contract Documents.

The Additive Bid scope to include hydroseeding of the Base Bid project area of 8.66 acres.
