## **Snoqualmie Valley Track Club Scholarship Fund**

The Snoqualmie Valley Track Club Scholarship Award, hereafter referred to as "The Fund" is a program of Si View Community Foundation. The Fund was established by Forrest L Sword as a means to reward youth who exhibit the characteristics of sportsmanship, leadership, and volunteerism, who at the same time wish to further their own personal development via higher education and training.

Any monies, be they from gifts, donations, grants or any other form of contribution will be distributed solely under the direction of Si View Community Foundation. It is further intended that any monies gifted or bequeathed to the fund will be used in perpetuity. Gifted or bequeathed monies will be invested in secure income producing securities and only the income produced by said funds will be available for distribution thereby assuring the perpetuity of The Fund.

Qualification standards for receipt of scholarship awards are identified as Addendum A. The qualification standards may be modified from time to time by Si View Community Foundation. Award amounts may also be modified from time to time at the sole discretion of Si View Community Foundation. Award amounts will be determined in part by the number of qualified applicants as well as the amount of funds available and the performance of any investments contained in the fund.

In addition to the above mentioned qualification standards, applicants must prove current enrollment in a certified institution of higher education including but not limited to; colleges, universities and community colleges. Applicants enrolled in certified trade schools or technical institutions are also eligible for award consideration.

All awards monies will be made to the certified institution referenced above for the benefit of the recipient. At no time will awarded funds be made directly to the recipient.

It is intended that award recipients may apply for awards in subsequent years but can only qualify by continuing to meet the current qualification standards including completing the volunteer hours requirement. No recipient shall receive more than 4 annual awards.

## **ADDENDUM A**

## **Snoqualmie Valley Track Club Scholarship Applicant Qualifications**

Si View Community Foundation will establish a scholarship award committee consisting of minimum of 3 current board members. Committee members will be appointed by the president or his/her assignee. Any committee member who has children nominated for consideration for a Scholarship Award will be deemed ineligible to participate in the selection process for their own child.

Applicants will be selected and judged on the following criteria in order of priority.

- 1) Nomination for consideration from SVTC members, program coordinators or coaches.
- 2) A minimum of 24 hours of volunteer service to Snoqualmie Valley Track Club (SVTC). Qualified hours may be earned assisting with All Comers meets, Jr Wildcat/Wildcat programs, or other SVTC related duties approved by SVTC program coordinator.
- 3) Years of service to SVTC.
- 4) Applicants must exhibit & promote characteristics consistent with SVTC goals & purpose such as, but not limited to, leadership, sportsmanship, positive attitude & teamwork.
